TRUSTEES' REPORT

For the financial year ended 5th April 2019

The Board of Trustees present herewith their report and the externally examined financial statement for the year ended 5th April 2019.

OUR ORGANISATION

The Eritrean Relief Association in United Kingdom has been registered as a UK charity and constituted as a company, limited by guarantee since 1988. ERA-UK has been operating and providing services as an unincorporated association since 1976 when it was founded. It is governed by a Memorandum of Articles of Association and the Board of Trustees is responsible for setting the strategic direction of the organisation and establishing policies. All Trustees are unpaid professionals with diverse managerial and volunteering experiences. The Trustees are appointed by the Board on the recommendation of the other Directors.

ACHIEVEMENTS

Towards the furtherance of our objectives this year, ERA-UK:

- Organised a sponsored run to take part in the British10K London Run July 15 2018 raising £4,913.00 towards supporting the Abraha Bahta School of Blinds, Association for the Blinds and children's project and other ERA's education development projects.
- Fundraising through charity collection boxes placed at groceries and newsagents, individual donations, standing orders and sale of items totals £2,688.00.
- £3,000.00 donation from Money.co.uk through the nomination of ERA UK by Michael Yohannes an employee of the company.
- As a result of active fundraising activities and events ERA UK has claimed a gift aid from HMRC a total amount of £4,045.00
- Mesfiney's Love Foundation donated £2,000.00 to support ERA UK's projects of children with special needs.

HOW WERE THE FUNDS SPENT

This year, ERA-UK projects were involved in support of Abraha Bahta School for the Blind in Asmara and the National Association of the Blinds in Eritrea. A total of £6,230 was spent in the supply of educational and special needs equipment including lap tops, Braille terminal, IT accessories, audio visual equipment, teaching materials, talking watches, walking canes and freight costs.

RESERVE POLICY

For the financial year 2019/20 ERA UK Board of Directors and Trustees have agreed to redesignate a total of £21,052.00 for earmarked specific projects and allocated £6,818.00 for funding contingency including office rent and administrative expenses; the remaining balance of £30.701.00 as a reserve fund for emergencies, relief and back up.

RISK MANAGEMENT

The Trustees have reviewed the major risks to which the charity organisation may be exposed and have taken the necessary steps to mitigate such eventualities.

ACKNOWLEDGEMENTS

The Board of Directors and Trustees gratefully acknowledges all financial donations, the tireless efforts of the sponsored runners, numerous businesses that raised funds by displaying ERA-UK collection boxes in their shops and general support shown by volunteers and all who care for the welfare of Eritrea without whom we could not provide the services that we do.

Additionally, ERA-UK is grateful for the following benefits in kind and for the generous events in support of its works during this period.

- The Accounts Report was independently examined by Mr. Tekle Tesfaye MAAT for which he has made no charge.
- Ms Tsige Ghebrekristos a Member of Accountant Technicians has kindly worked out the accounts for inspection by our external assessor/reporting accountant.
- Michael Yohannes an employee of Dot Zinc money.co.uk for nominating ERA UK as a charity of the year and have donated £3,000.

APPEAL

ERA-UK has no paid workers for its day-to-day running operations and is therefore able to allocate 90% of all funds raised to go directly to target projects and other charitable activities. The largest outgoing is office rent at £1,818.00
